Innovations and New Features

LLED 8888 was created as a doctoral seminar for JoLLE to conduct its business. Prior to the establishment of this 3-hour course, JoLLE had been operated above and beyond course credit, and had struggled to gain participation. The course provided an infrastructure through which JoLLE's editing could be undertaken.

The editorial board underwent a complete overhaul to create specific responsibilities. New positions were created to divide labor and create accountability for each role in the journal. These included Managing Editor to be responsible for manuscript flow, charting, and reviewer assignments; Production Editor to oversee the conversion of manuscripts to edited pdf documents for publication; Website Editor to manage the renovated JoLLE Website, with the Principal Editor responsible for social media presence and promotion. In the fall of 2013, JoLLE launched a new feature, "Poetry and Arts," which was first published in issue g(2) featuring two visual art pieces and five poems. It was edited by feature founder Susan Blyle.

JoLLE developed a new record keeping program for documenting manuscripts received, peer reviews assigned, and decisions, using spreadsheets to keep track of manuscript flow and changing the manuscript coding procedures.

JoLLE Conference

The inaugural JoLLE@UGA 2013 Winter Conference was co-chaired by Lindy L. Johnson and Tobie Bass Trudeau, with the theme Activist Literacies: Inspire, Engage, Create, Transform. Keynote speakers were Glynda Hull, K.C. Nat Turner, and Christian Faltis.

Conference co-chairs Lindy L. Johnson and Tobie Bass Trudeau were awarded the "Bulldog Vision Award" from the UGA Student Organization Achievement and Recognition (S.O.A.R.) Award for the JoLLE Winter Conference.

Manuscript Submission and Acceptance

Manuscript Submission and Acceptance Statistics are recorded across editorial terms, so for the 2013-2014 school year, under Stephanie Anne Shelton, 103 manuscripts were received, 41% received revise and resubmit decisions, and 25% of manuscripts were accepted.
